The Appeal mechanism usually lasts for five years. A group wishing to oppose the above applications had a meeting with a trademark lawyer about this very topic. The lawyer explained about the process and informed them that even though someone were to challenge the GC trademark, the GC had the means to bury them in paperwork for years and years.

It is also interesting to note that the letters "EGW" were trademarked by the GC in 1985! So step by step a pattern is developing.
